The Marshfield Fire Protection District is currently seeking qualified vendors to participate in a bid process for firefighting turn-out gear for use during our 2024-2025 budget years.

Title: Turn-Out Gear

Bid Requirements:

- Bids must be submitted and received by March 18th, 2024, at 2:00 PM by email, postal mail or hand delivery.
- Bid must include specified equipment; substitutions may be allowed if equal or greater quality.
- Each “bid sheet” should include one pair bunker pants, one bunker coat, one pair suspender.
- Each bidder should provide a data sheet indicating the TPP and THL of the gear assembly being bid.
- Bid must include a per unit cost and a total cost and then any additional charges, such as shipping, larger size pricing, etc.
- Vendor should be able to provide sizing for personal protective equipment or provide 30-day, unworn return policy to allow for sizing deficiencies at no additional charge.
- Vendor may at their discretion provide more than one bid. If this option is chosen each bid shall be on a separate bid sheet. Example: Vendor sells two manufactures of gear. Manufacturer “A” is on bid sheet 1 and Manufacturer “B” is on bid sheet 2.
- Vendor must ship all items in this bid together, or at least in “complete sets” as designated by the order.
- Vendor must have the ability to deliver all ordered items within one hundred eighty (180) days from the date the order is placed by MFPD.
- Submitted bids must be valid for a full twelve-month period.
- Bidder should be available to demo the items bid as requested.

This is **not** a sealed bid process; therefore, bids will be reviewed for pricing, quality of material, and services provided.

Closure: Zipper and Velcro

Reflectivity: NYC Style Lime Green / Silver Triple Trim

Pockets: Hand warmer / Cargo Pocket, Left Chest Radio Pocket, Right Chest Flashlight Attachment or Utility Strap

Special Requirements: Nomex or Kevlar (or comparable) Wristlet, Drag Rescue Device, Reinforced elbows and shoulders Dragonhide or comparable/superior, "MARSHFIELD" in Reflective, Sewn Letters on Back

Outer Shell: Fusion Material, Aramid Blend, Tecgen 71, ARMOR or comparable/superior

Moisture Barrier: Gore TR 7100, RT7100 PTFE, STEDAIR 4000 or comparable

Thermal Liner: Glide Ice 2 or comparable/superior

Closure: Zipper and Velcro or Zipper, Velcro, and Snap

Reflectivity: NYC Style Lime Green / Silver Triple Trip

Pockets: Two Bellow Pockets, Right Pocket Divider

Special Requirements: None

Style: "H" style

Special Requirements: Must be quick adjustment style such as "parachute pull loops". Metal attachment points.

Item Specification: Coat Name Flap

Attachment: Metallic Snap on Bottom Rear Coat Panel

Panel: Coat Material with 4" Sewn Reflective Letters of Name Provided
